

**THIS PAGE:** SOU students pull Scotch broom on Elk Island.




# Elk Island – Rogue River Preserve

Land in Flux: avulsion, erosion, saltation, sedimentation









ooking at a 1940 aerial photograph of the Rogue River Preserve, a 352-acre property SOLC owns near Eagle Point, the vernal pools, streamside forests, and woodlands are easy to pick out. But something is missing. Where is the island we call Elk Island?

Dynamic stream processes are constantly taking stream banks here, and building land there. River islands are ephemeral features of the Earth. Today the 16-acre island has lupine-dotted sandy meadows, a cottonwood swale with a mucky stream bottom, and is fringed by alder, willow, and nonnative Himalayan blackberry. It is a refuge for breeding Willow Flycatchers and browsing elk.

In the future? Who knows? Nonetheless, we honor our commitment to steward the whole property and regularly visit the island to pull invasive Scotch broom and English ivy, pick up trash brought by winter floods, and monitor for new threats.



# **Sharing Knowledge and Passion for the Natural** World is a Role We Take to Heart

### Students on the Land

Our Loving the Land program, now in its 14th year, has engaged more than 3,000 students from the Ashland and Talent/Phoenix school districts. For five days, Oredson-Todd Woods is transformed into a learning center for adventure, exploration and creativity, under the guidance of stewardship staff and enthusiastic volunteer educators. We also hosted the Roots & Shoots Club, middle school students from John Muir School, and Boy Scouts on education, restoration and trail building projects on conserved lands. These experiences connect youth to nature, teach them how to work together, and help them understand the important role they play in caring for our environment.

### **Diagin' In Work Parties**

Throughout the year, rain or shine, volunteers show up for work parties on conserved lands. From pulling invasive weeds or planting

native plants to clearing trails, we are so very grateful for the volunteers who roll up their sleeves and dig in! In 2018, volunteers mowed, built trails, erected bird houses, removed old barbed wire fencing and trash, and pulled noxious weeds.

### Hikes and other Explorations

What in the world is a herptile bioblitz? Well it happened on the Rogue River Preserve, along with wild mushroom hunting, birding and a dragonfly excursion. History hikes in the Jacksonville Woodlands and on Upper Table Rock were also part of 2018's hike series, along with wildflower exploration and more birding in the Cascade Foothills. You may have even had the thrill of catching butterflies on the gorgeous Sky King Cole property. These were just a handful of experiences that made up more than 22 hikes, outings, and community events put on by SOLC last year, and more than 373 enthusiastic community members

participated! We are so grateful to our marvelous and talented volunteers who lead these adventures for us every year.






## SOLC Adds Three Conservation Easements, **287 Acres Under its Protection**

 $\checkmark$  onservation easements are a way for private landowners to ensure that their vision for their land, Ulifelong stewardship, and family heritage live on for generations to come. Conservation easements promote best management practices, while restricting or limiting activities that may diminish the natural value of the land, such as clear-cutting, subdivision, and intensive development.

Lands that have "high conservation values"-determined by size, diversity, and uniqueness of the property—are likely eligible for a conservation easement. Working lands (e.g., farms, ranches, and forests), relatively undisturbed and diverse habitat, and lands with unique features (e.g., major streams and rivers or a scenic view) may also fall into this category.

In 2017-18, three new conservation easements were donated to SOLC.



### ▲ Colestin Valley

This wonderful 160-acre property is strategically located in the Colestin Valley, adjacent to the Klamath National Forest to the west and bounds the Cascade-Siskiyou National Monument to the east. The protection of this property with a conservation easement helps preserve a corridor of private land between BLM and Cascade-Siskiyou National Monument lands to the east and US Forest Service land to the west. This area is one of the

most important ecological corridors in Oregon for wildlife and biodiversity, and is also an SOLC Focus Area. The property contains oak woodland, meadows, chaparral, and forests. Special status plants known on the property are the Southern Oregon buttercup, Ashland thistle, and golden triteleia. Many special status animals have also been documented including Band-tailed Pigeons, and the property is important deer and elk winter range.

### ▲ East Fork Illinois River

A conservation easement on this 80-acre property protects 2,000 feet of amazing riparian habitat along the East Fork Illinois River and 1,500 feet along a stream in Cedar Gulch. Both streams are important for supporting salmon and steelhead spawning and rearing habitat. The property is located upriver from a 255-acre easement SOLC holds on the Illinois River. It contains upland forests, oak woodlands, chaparral, and meadows. Special status species on this easement include Northern Spotted Owl, Acorn Woodpecker, coho salmon, Chinook salmon, Pacific fisher and foothill yellow-legged frog. It also supports flower endemics like the Siskiyou trillium. Strategically, the property is in an SOLC focus area, provides aquatic, streamside, and upland corridor for wildlife, and is near a large contiguous portion of the Rogue-Siskiyou National Forest connected to the Siskiyou Wilderness.

### **Sardine Creek**

This property has been cared for and stewarded for many years, and the conservation easement was donated to SOLC in 2018. The 47-acre property is on the Left Fork of Sardine Creek, a fish-bearing perennial tributary of Sardine Creek which flows into the Rogue River. This special property contains mixed evergreen and hardwood forest with openings, riparian areas, and oak woodland/ chaparral patches. The forest has been wellmanaged and selectively logged and, although portions have burned, there are many older trees remaining. Plants and wildlife are abundant, and the property is adjacent to BLM lands, some designated old growth forests, and habitat for the Northern Spotted Owl.
